There are no costs or fees for recruitment or any advice provided regarding employment issues relating to people/ employees with disabilities. You will be able to access untapped labour resources within Guernsey and you will be able to enhance diversity within your workplace.

By adopting good practice you will be compliant with the Disability Discrimination Act/Equality Act (for UK companies) and you will be demonstrating your commitment to Corporate Social Responsibility agendas. You can be one step ahead of the forthcoming disability legislation to be introduced in Guernsey and you can provide job opportunities for the local community.

You will receive a friendly, professional and flexible range of support that can benefit both your organisation and your employees.

### What can employers do?

Employers can provide employment opportunities, work experience placements or job tasters for job seekers with disabilities. Employers can encourage applications from people with disabilities and submit job vacancies to disability organisations such as Guernsey Employment Trust.

Employers can be proactive and participate in mock interviews and give feedback on job interviews, job applications and job seeker's CV's. Employers can recognise the potential business case for employing a person with a disability and can adopt policies and procedures that demonstrate good practice.

Employers can show flexibility and willingness at all stages of the recruitment and selection process and have

a positive attitude to retention and redeployment matters relating to people with disabilities. Employers can make reasonable adjustments for job seekers and employees.
